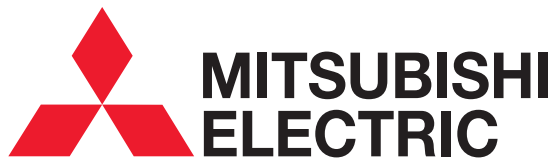

Purchase a new qualifying Mitsubishi System Between June 15, 2009 and July 31, 2009.

Download the mail-in rebate form at <http://www.mrslim.com/rebate/> and fill in all the required information. Include the following items in an envelope:

- Completed comfort rebate form including model and serial numbers.
- Copy of contractor's invoice proving the purchase is a qualifying system purchased from, and installed by, a qualified contractor between June 15, 2009 and July 31, 2009. Must show your name, address and phone number; the contractor's name, address and phone number; date of installation and model and serial numbers of indoor and outdoor units.
- Completed Warranty Registration Card found in the indoor unit box of your new system.
